

## Self-certification regarding tax status for individuals

### Self-certification tax residency

#### NOTE

The Liechtenstein Government has agreed and will agree a number of inter-governmental agreements to share tax information, where applicable, with the tax authorities in other jurisdictions (FATCA<sup>1</sup> agreement with the USA, AEOI<sup>2</sup> agreement with many countries worldwide with more countries to join). The requirement to collect certain information about each customer's tax arrangement is part of Liechtenstein legislation and as a life insurance company; we are legally obliged to collect it. We are asking for your tax residency and tax ID numbers (where applicable) and will record this on our records now, but will only disclose this information to the relevant tax authorities if and when we are required to under Liechtenstein law.

Your tax residence generally is the country in which you live for more than half a year. Special circumstances (such as studying abroad, working overseas, or extended travel, place or date of birth in the US) may cause you to be resident elsewhere or resident in more than one country at the same time (dual tax residency). The country/countries in which you are a general taxpayer is/are likely to be your country/countries of tax residence.

### According to US tax law the term US-person means any of the following

- Citizens of the United States. Dual citizens of the United States and another jurisdiction (note: US-citizenship is generally acquired upon birth in the United States or on U.S. territory and remains valid unless revoked or in case of other special circumstances, e.g. children of diplomats);
- Persons meeting the „substantial physical presence requirements“ (persons, who have spent more than 31 days of the current year and 183 days in total in the United States, counting all days of presence within the current year, 1/3 of the days in the previous year and 1/6 of the days in the penultimate year); or
- Legal permanent residents of the United States at any time during the current calendar year (e.g. Green Card holders);
- Persons subject to U.S. tax for any other reasons.

If you are not sure if you meet one or more of these conditions **we recommend to consult your legal or tax advisor**
